

## Riviera Maya June 2026 Mini FAM Program — Terms & Conditions

These Riviera Maya June 2026 Mini FAM Program Terms & Conditions (these “Terms & Conditions”) govern and apply to participation in Travel Edge’s June 2026 Riviera Maya Mini FAM (the “Mini FAM”). By enrolling in the Travel Edge Network Venture Program (the “Venture Program”) during the Offer Period (defined below) and/or accepting or participating in the Mini FAM, you agree to be bound by these Terms & Conditions. In these Terms & Conditions, references to Travel Edge or Travel Edge Network mean Travel Edge (Canada) Inc. and Travel Edge (USA) Inc.

Participation in the Mini FAM is available on a first-come, first-served basis to the first eight (8) eligible individuals who successfully enroll in the Venture Program by completing the Enrollment Steps (defined below) during the period beginning at 12:00 a.m. EST on December 18, 2025 and ending 11:59 p.m. EST on January 31, 2026 (the “Offer Period”); provided that Travel Edge may extend the Offer Period in its discretion if fewer than eight (8) Mini FAM spots have been filled by January 31, 2026.

**Early Access Eligibility Window.** This Mini FAM offer is made available during the Early Access Period exclusively to individuals identified in Travel Edge’s records as having previously expressed interest in the Venture Program at any time from October 1, 2025 through 11:59 p.m. EST on January 4, 2026 (for example, by submitting an inquiry or starting but not completing registration/enrollment). Beginning January 5, 2026, if Mini FAM spots remain, the offer may be made available more broadly to the public; however, Mini FAM spots will remain subject to availability and awarded based on the order of successful enrollment (first-come, first-served) while supplies last. For clarity, once all eight (8) spots are filled, no further Mini FAM spots will be awarded regardless of the remaining Offer Period.

**Eligibility.** This offer is open only to legal residents of Canada and the United States who are eighteen (18) years of age or older (or the age of majority in their state or province of residence) at the time of enrollment. Travel Edge may require proof of eligibility and may disqualify any individual who does not meet these eligibility requirements.

**Successful enrollment; ordering.** For purposes of these Terms & Conditions, “successful enrollment” means completion of both of the following steps (the “Enrollment Steps”): (i) acceptance (or re-acceptance) of the Travel Edge Venture Program agreement (the “Venture Program agreement”) via the designated enrollment form, and (ii) submission and receipt of the required initial payment in accordance with your selected payment plan, which must remain in good standing (no chargeback/reversal).

**Re-acceptance required.** Even if an individual previously accepted the Venture Program agreement, the individual must accept (or re-accept) the Venture Program agreement using the designated enrollment form during the Offer Period to qualify for a Mini FAM spot.

**Determination of order.** The order of successful enrollment for purposes of the first-come, first-served allocation will be determined based on Travel Edge’s systems and records reflecting when both Enrollment Steps are complete, and such determination will be final.

**Identity verification/background check; conditional award.** Travel Edge may require identity verification and/or a background check as part of the enrollment process (or thereafter) to the extent permitted by applicable law and in accordance with Travel Edge's [Privacy Policy](#). A Mini FAM spot may be reserved or awarded on a conditional basis pending completion and satisfactory results of any such verification/background check. Failure to timely complete or pass any such verification/background check to Travel Edge's satisfaction may result in disqualification and forfeiture of the Mini FAM spot (and, if applicable, Venture Program enrollment may be deemed not in good standing and/or may be cancelled in accordance with the Venture Program agreement).

**Conditions to earn and retain a Mini FAM spot.** Participation in the Mini FAM is conditioned on: (a) successful completion of the Venture Program by May 15, 2026, in accordance with the Venture Program agreement and all applicable program requirements, including (i) attending 15 live sessions (or watching recordings) and submitting homework, (ii) completing 26 e-learnings, (iii) completing 10 Destination Guide courses, and (iv) completing 2 Partner Certifications; (b) maintaining an active Travel Edge Network membership through the end of the Mini FAM, including timely payment of any amounts owed to Travel Edge Network (without chargeback/reversal); and (c) remaining in compliance at all times with the Venture Program agreement, all Travel Edge policies (including any code(s) of conduct and anti-harassment / non-discrimination policies), and all applicable laws and regulations. Travel Edge may verify eligibility and compliance at any time and may disqualify any registrant who does not meet these requirements or revoke a Mini FAM spot at any time if conditions are not met.

**Reallocation of forfeited spots.** If any of the first eight (8) individuals awarded (including conditionally awarded) a Mini FAM spot is deemed ineligible, fails or does not timely complete identity verification and/or any required background check, fails such verification/background check, declines, or does not participate for any reason, the Mini FAM spot will be offered to the next eligible individual in the order of successful enrollment (as determined under these Terms & Conditions based on Travel Edge's records), until all available spots are filled or no additional eligible individuals remain.

**Non-transferability; no cash alternative.** The Mini FAM must be accepted as provided and is not transferable, assignable, or convertible to cash, and no substitution is permitted except as determined by Travel Edge in its sole discretion.

**Guest policy.** Travel Edge may, in its discretion, permit the traveler to invite one (1) guest to participate for an additional fee, subject to availability and any requirements established by Travel Edge. Any approved guest must comply with applicable program terms and execute any required release documentation.

**Program details; changes; cancellation. Anticipated details.** The Mini FAM is currently anticipated to take place June 13–17, 2026 at Grand Velas Riviera Maya on an all-inclusive, single-occupancy basis. Flights are not included. The nature and scope of the Mini FAM, including travel location, travel dates, itineraries, and inclusions (and any details not expressly specified), are determined by Travel Edge. Travel Edge may modify, reschedule, or substitute the Mini FAM with an

experience or item of equal or greater value due to operational, safety, supplier, or availability reasons. Notwithstanding the foregoing, if the Mini FAM is cancelled because of force majeure or other circumstances outside Travel Edge's reasonable control (including, for example, weather, natural disasters, public health events, government actions or travel restrictions, transportation interruptions, or supplier cancellations), Travel Edge may cancel without liability and without providing any substitute benefit or compensation.

**Attendance; conduct.** Attendance at all scheduled on-site activities and group meals during the Mini FAM is required. Participants (and any approved guest) must comply with all Travel Edge policies and any supplier or property rules, and Travel Edge may remove any participant (and/or guest) from the Mini FAM for non-compliance, unsafe behavior, abusive behavior, harassment or other disruption, with no substitute benefit or compensation.

**What is (and is not) included.** Flights are not included unless expressly stated in writing. All costs not specifically stated as included are the sole responsibility of the traveler (and any approved guest), including ground transportation, baggage fees, documentation (passport/visa), insurance, incidentals, tips/gratuities, and applicable taxes. Any unused portion of the Mini FAM may be forfeited with no substitution.

**Release.** Participation requires signing Travel Edge's liability release (and guest release, if applicable) by the stated deadline. Failure to timely sign required releases may result in forfeiture of the Mini FAM spot, in which case the spot may be offered to the next eligible individual as described above.

**ARV; taxes.** The approximate retail value ("ARV") of each Mini FAM spot is \$4,500 USD (Total ARV for all eight (8) Mini FAMs \$36,000 USD). The Mini FAM may be taxable as income, and the traveler is solely responsible for all taxes, reporting, and any related liabilities.

**Disclaimer.** The Mini FAM is provided "as is" without warranty of any kind, express or implied.

**Limitation of liability.** TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, TRAVEL EDGE (INCLUDING ITS AFFILIATES, AND ITS AND THEIR RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, CONTRACTORS, AGENTS, SUCCESSORS, AND ASSIGNS) WILL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, EXEMPLARY, OR PUNITIVE DAMAGES, OR FOR ANY LOSS OF PROFITS, REVENUE, BUSINESS, GOODWILL, DATA, OR OPPORTUNITY, ARISING OUT OF OR RELATING TO THE MINI FAM, THESE TERMS & CONDITIONS, THE VENTURE PROGRAM, OR ANY TRAVEL, LODGING, ACTIVITIES, OR SERVICES PROVIDED BY THIRD PARTIES, WHETHER BASED IN CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, OR ANY OTHER LEGAL THEORY, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, TRAVEL EDGE'S TOTAL AGGREGATE LIABILITY ARISING OUT OF OR RELATING TO THE MINI FAM OR THESE TERMS & CONDITIONS WILL NOT EXCEED THE AMOUNT PAID TO TRAVEL EDGE BY THE PARTICIPANT FOR PARTICIPATION IN THE VENTURE PROGRAM BETWEEN DECEMBER 18, 2025 AND MAY 15, 2026. Some jurisdictions

do not allow the exclusion or limitation of certain damages or liability; in such jurisdictions, the above limitations apply only to the extent permitted by law.

**Arbitration (U.S. residents only); class action waiver.**

(a) **Applicability.** If you are a legal resident of the United States, you and Travel Edge agree that any dispute, claim, or controversy arising out of or relating to the Mini FAM or these Terms & Conditions (each, a “Dispute”) will be resolved by final and binding arbitration, rather than in court, except as expressly set out below.

(b) **Administrator; rules; seat.** The arbitration will be administered by the American Arbitration Association (“AAA”) under its Consumer Arbitration Rules (or other applicable AAA rules), as modified by these Terms & Conditions. The seat/venue of arbitration will be Wilmington, Delaware, unless the arbitrator determines another location is appropriate under the AAA rules.

(c) **Individual basis only; no class actions.** Arbitration will be conducted only on an individual basis. You and Travel Edge waive any right to have any Dispute brought, heard, administered, resolved, or arbitrated as a class, collective, representative, or mass action, and the arbitrator may not consolidate claims or award relief on a class-wide basis.

(d) **Carve-outs.** Either party may seek temporary or preliminary injunctive relief in a court of competent jurisdiction to prevent irreparable harm (for example, misuse of intellectual property or confidential information) pending completion of arbitration.

(e) **Time limit.** Any Dispute must be brought within the time period permitted by applicable law.

(f) **If unenforceable.** If this arbitration provision (including the class action waiver) is found unenforceable as to a particular claim or remedy, that claim or remedy (and only that claim or remedy) will be severed and resolved in court as set forth in the Jurisdiction/Venue section below.

**Severability.** If any provision of these Terms & Conditions is held to be invalid, illegal, or unenforceable in any respect, the remaining provisions will remain in full force and effect. Any invalid, illegal, or unenforceable provision will be deemed modified to the minimum extent necessary to make it valid, legal, and enforceable while most closely reflecting the parties’ original intent.

**Waiver.** Travel Edge’s failure at any time to require performance of any provision of these Terms & Conditions (or to enforce any right or remedy) will not be deemed a waiver of such provision, right, or remedy. No waiver by Travel Edge will be effective unless in writing, and any waiver will apply only to the specific instance and purpose for which it is given. The exercise of any right or remedy by Travel Edge will not preclude any other or further exercise of that or any other right or remedy.

**Governing law; jurisdiction; venue.**

**U.S. Residents:** If you are a legal resident of the United States, these Terms & Conditions and any dispute, claim, or controversy arising out of or relating to the Mini FAM or these Terms & Conditions will be governed by the laws of the State of Delaware, without regard to its conflict of laws principles. To the extent any Dispute is permitted to proceed in court (including for injunctive relief or if the Arbitration provision is found unenforceable as to a particular claim), the parties irrevocably submit to the exclusive jurisdiction of the state and federal courts located in Delaware

and waive any objection to venue in such courts.

**Canadian Residents:** If you are a legal resident of Canada, these Terms & Conditions and any dispute, claim, or controversy arising out of or relating to the Mini FAM or these Terms & Conditions will be governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein, without regard to conflict of laws principles. The parties irrevocably submit to the exclusive jurisdiction of the courts located in Toronto, Ontario and waive any objection to venue in such courts.

**Travel Edge discretion.** Travel Edge's decisions regarding interpretation and application of these Terms & Conditions, including eligibility determinations and award (including conditional award) of Mini FAM spots, are final and binding to the maximum extent permitted by law.

**Modification of Terms & Conditions.** Travel Edge may update or modify these Terms & Conditions from time to time or terminate this offer in its sole discretion. Any such updates will be effective as of the date they are posted or otherwise communicated by Travel Edge, and will apply prospectively. For clarity, no modification will retroactively eliminate a Mini FAM spot that has already been awarded based on successful enrollment, except to the extent necessary to comply with applicable law or to address fraud, abuse, or material violations of these Terms & Conditions, the Venture Program agreement, or Travel Edge policies.

**Order of precedence.** Participation in the Mini FAM and the Venture Program is also subject to the Venture Program agreement and Travel Edge policies. In the event of any conflict or inconsistency: (a) with respect to the Mini FAM (including eligibility for, earning, retaining, or participating in a Mini FAM spot), these Terms & Conditions will control; and (b) with respect to the Venture Program (including enrollment, fees, cancellations, termination, and program participation), the Venture Program agreement will control. Travel Edge policies will apply to the extent they do not conflict with the foregoing.
